We are excited to welcome you and your child/children to our After-School Program here At Mr. Robert's. In this Parent Handbook, you will find important information about our updated policies and procedures.

This handbook serves as an integral part of the enrollment agreement between our program and the parents/guardians of the enrolled children. We kindly ask that you take a few moments to review all the enclosed information.

Our After-School Program offers four key components. We provide care for students from school dismissal until 6:30 PM, Monday through Friday, including on early dismissal days. On school closure days, we are open for full-day care starting at 8:00 AM until 5:00 PM for an additional fee of \$150.00 per day. If you're interested, please feel free to reach out to me. Additionally, we offer a Summer Camp that runs for 10 weeks.

Our program operates on a monthly tuition basis and we do not offer prorated or paused tuition due to schedule changes or outside activities. Tuition reserves your child's space in the program and is not based on attendance.

As a small program, we must apply our policies consistently to all families and unfortunately are not able to make individual exceptions.

REGISTRATION

There is a non-refundable registration fee of \$150.00 per child for After School. This fee may be included in the first payment.

All parents must provide an accurate and up-to-date health and immunization record at the time of registration.

Please fill out the attached emergency contact form and return it as soon as possible. Also note if your child has any allergies.

\$1,000 Monthly – After School Pick Up & Early Dismissals.

**School dismissal-6:30pm
8:00am-5:00pm**

- If you choose not to use us for the Early Dismissal you **WILL NOT** be able to drop off your child. We plan our staff according to how many children we have for that day.
- All After School Program students **MUST** be picked up by 6:30pm. There will be a \$20.00 per 15 minutes charge for any child picked up after 6:30pm. Prompt payment to an AT MR. ROBERT'S staff member will be issued upon picking up your child.

EMERGENCY CONTACTS & CHILD RELEASE AUTHORIZATION

Children will not be released to anyone whose name is not on the following list, without permission from the parent. In emergency cases, parents must call the Director and provide enough documentation to enable the individual to pick up your child.

Please provide a picture and identification for each person listed below. We will not release any child to a person or persons whom we feel is not capable of caring for your child. Your signature below states that you give us full permission to release your child to the individual(s) name below. By signing below, you also agree that we can use your best judgment and not release your child to the named individual if we feel this is not the best interest of your child (intoxicated, angry, lack of car seat, etc.)

If a parent or another person is specifically “not” authorized to visit or pick-up a child, please provide us with the appropriate court documentation. The center will not be put in a position of defending either parent and/ or guardian. We will always defend the right of the child to have a safe and positive environment free of any turmoil and negative disturbances.

DISCIPLINE POLICY AND BEHAVIORAL ISSUES

At Mr. Robert's, we expect participants to show respect for others and their personal space, engage harmoniously in activities, cooperate with staff, and maintain a positive attitude. Learning self-control is a natural part of growing up, so we never embarrass or belittle a child for misbehaving. Instead, we focus on positive strategies that boost children's self-esteem. We may use a "time-out" as a tool for children to reflect on their actions before rejoining group activities. This is a constructive form of discipline that helps children understand appropriate behavior while giving them the opportunity to choose to improve.

Unacceptable behaviors include profanity, disrespect toward others, failure to follow staff instructions, excessive roughhousing, and inappropriate or violent physical contact.

Given that we provide childcare in a group environment, we must prioritize the safety and well-being of all children and staff. Mr. Robert's will notify the parents/guardians of all children involved in any incidents of unacceptable behavior. We reserve the right to suspend or expel any child for inappropriate conduct.

SICKNESS POLICY

If your child gets sick, it is often most appropriate to keep him/her home from school. A child who is sick will not be able to perform well in school and is likely to spread the illness to other children and staff. Please make arrangements for childcare ahead of time so you will not be caught without a place for your child to stay if he/she is ill.

At Mr. Robert's guidelines state that you should not send your child to school if he/she has any of the symptoms below.

If your child has any symptoms from 1-5 your child MUST take a Covid Test in order to return to our facility.

1. Fever in the past 24 hours 99 degrees or higher
2. Vomiting in the past 24 hours
3. Diarrhea in the past 24 hours
4. Strep Throat (must have been taking an antibiotic for at least 24 hours before returning to our facility).
5. Bad cold, with a very runny nose or bad cough, especially if it has kept the child awake at night.
6. Head lice – live bugs or nits (lice eggs)
7. Rash
8. Pinkeye- (must be on antibiotic eye drops for 24 hours, which includes 4 doses, before returning to our center)

If your child becomes ill at our center, or is contagious to other children, you will be called to come and take him/her home from our facility. It is essential that your child's teacher have a phone number where you can be contacted during the day and an emergency number in the event you cannot be reached.

If your child has been sent home by one of our staff members for any of the above reasons, he/she will not be permitted to return to school until after the appropriate period of time has passed and will not be allowed to return without a doctor's note.

At Mr. Roberts follows the school district's health guidelines. Any child sent home from school for illness or not cleared to return to school may not attend our program until they meet the school's return requirements.

TUITION PAYMENT CONTRACT AND CANCELLATION POLICY

- 1. Payment Schedule:** The total tuition for school aftercare services amounts to \$10,000.00 and shall be paid over a period of 10 months. The payment schedule shall commence upon the start date of aftercare services.
- 2. Monthly Installments:** The total tuition shall be divided into equal monthly installments of \$1,000.00 each.
- 3. Payment Due Date:** Monthly payments are due on the 1st day of each month. Payments shall be considered received upon receipt by the At Mr. Robert's facility.
- 4. Cancellation Policy:** The contract for payments is binding for the entire duration of the agreed-upon 10-month period. Cancellation of the payment contract shall only be permissible under previously approved emergency circumstances. Such circumstances must be documented and approved by Robert Mosley. Cancellation requests must be submitted in writing and will be reviewed on a case-by-case basis. A minimum of two (2) months' written notice is required prior to the requested cancellation date.
- 5. Penalties for Non-Payment:** Failure to make timely payments may result in penalties, including but not limited to late fees or suspension of daycare services until outstanding payments are settled.
- 6. Tuition** is considered an annual tuition, as like most other centers. If your child is enrolled in our center but does not attend, full tuition payment is required on the normally scheduled payment day. Thus, we charge a full week's tuition if your child misses a part of our entire week due to: family vacation, sick day, sent home sick, or we may have to close for serious or severe weather.
